Chief – explains the maintenance plan replacing portables and maintenance for upgrade made to radios looking to level fund.

Chief – explains the increase for drop box for body cam footage. **D. Dion** – comments photography has been level funded at \$300 for years and motion to increase fund <u>01-4210-3-390-4 Photography</u> at \$500.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments what this line covers and asks that it be level funded. **D. Dion** – motion to level fund <u>01-4210-3-391-0 Public Relations</u> at \$3500.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments looking to level fund **D. McCarthy** – questions remaining balance funds. **Chief** – mentions costs covered by ARP Act. **D. Dion** – motions to level fund <u>01-4210-5-560-1</u> <u>Plant Costs</u>.at \$7,000.00. **D. McCarthy** - second. All in favor. **Motion passes.**

Chief – explains looking to reduce line. He outlines the ballistic vest maintenance plan as reason for reduction. **D. Dion** – motion to reduce fund <u>01-4210-6-610-1 Police Equipment</u> at \$5,200.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments the bulk of this time is associated to the maintenance plan cost of the department copier and request increase. **D. Dion** – motions to increase fund <u>01-4210-6-610-2</u> <u>Office Equipment</u> at \$2,300.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments looking for increase postage due to increase in PO box cost increase. **D. Dion** – comments this line has been at this amount for years. **D. McCarthy** – mentions the increase in postage stamps. **D. Dion** - motions to increase fund <u>01-4210-6-630-1 Postage</u> at \$700.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments level funding. **D. Dion** – mention to level fund <u>01-4210-6-640-1</u> <u>Subscriptions/Dues</u> at \$4,100.00. **D. McCarthy** – second. All in favor. **Motion passes**.

Chief – comments seeking level funding mentioning the taser annual purchase and increase to cost of ammo. **D. Dion** – motion to level fund <u>01-4210-6-660-1 Firearms</u> at \$5800.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – outlines what consists of this line and looks for level funding. **D. Dion** – motion to level fund <u>01-4210-6-660-2 Police Supplies</u> at \$2,250.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments right now K9 Athos is looking good for another year and requests level funding. **D. Dion** – motion to level fund <u>01-4210-6-660-3 Canine Supplies</u> line at \$3000.00. **D. McCarthy–** second. All in favor. **Motion passes.**

D. Dion – motion to level fund <u>01-4210-7-710-1</u> Commission at \$100.00. **D. McCarthy –** second. All in favor. **Motion passes.**

Chief – request level funding and outlines utilization of this line item. **D. Dion** – motion to level fund <u>01-4210-6-670-1 Office Supplies</u> at \$2,250.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – comments like to leave line level funded and in past was used for advertising for events and employment. **D. Dion** – motion to level fund <u>01-4210-6-680-1 Advertising</u> at \$200.00. **D. McCarthy -** second. All in favor. **Motion passes.**

Chief – outlines what costs include in line. **D. Dion** - motion to level fund <u>01-4210-6-690-1</u> <u>Other Contingencies</u> at \$200.00. **D. McCarthy** – second. All in favor. **Motion passes.**

Chief – reviews the cruiser plan for the next few years and what he envisions it will entail. He outlines leasing plan for two cruisers for 2022 and mentions each year planning for 4 items to keep future costs from substantially increasing. He further mentions the inclusion radar and laptop in line. **D. Dion** – mentions the cost of outfitting cruisers has risen. **Chief** – explains the plan to lease hybrid cruisers because of the fuel savings. **D. Dion** - asks about purchasing laptop and radar out of detail fund. **Chief** – explains detail funds have been used this month and was planning on discussing a little later in presentation. He mentions the funds would have to be for next year and could do that. **D. Dion** – reviews how many more line items are left. **Chief** – asks if the commission wants to come back to this line item. **D. McCarthy** – mentions coming back to this line and move on with budget presentation.

Chief – explains the purchasing the motorcycle is what the detail account surplus for 2021. He mentions the department will be meeting with Selectmen Monday to approve paying off the 2020 Harley with funds from the detail account which will roughly be the 10% that Selectmen annually authorized use of. He further explains the cost for annual MC maintenance and to outfit and officer and supplies. **D. Dion** – motion to reduce <u>01-4210-7-700-1 Motorcycle</u> approve line at \$1,500.00. **D. McCarthy** – second. All in favor. **Motion passes**

Chief – explains parts costs and outlines why the department is seeking an increase in this line until after market post and tire price down. D. Dion – mentions Ford making changes to style and size cruiser. Chief – comments on the fact the department is already over on this line. P. Bergeron – asks if lifetime warrantee is honored. D. McCarthy – mentions not on cruisers and mentions the Town of Rye's mechanic drives to Malden for parts and parts are made cheaply. D. Dion - motion increase fund <u>01-4210-7-710-1 Cruiser Maintenance</u> at \$13,300.00. P. Bergeron – second. All in favor. Motion passes.

Chief – mentions the department is spending about \$2000.00 in fuel costs each month, which will result in approximately \$1500.00 shortfall. **Chief** – comments the hybrid car helped. **D. Dion** – mentions with next year's additional hybrids they department will save more. **Chief** – mention to keep in mind the cruisers aren't into the fleet until sometimes as late as June and looking to increase line by \$2500.00. **D. Dion** – motion to increase <u>01-4210-7-720-1 Cruiser</u> <u>Fuel</u> to \$25,000.00. **P. Bergeron** – second. All in favor. **Motion passes.**

Chief – looks to move back to cruiser discussion and admits didn't think utilizing detail fund for those additional budgeted items. **L. Deeb** – comments that brings the line to \$56,448.00. **D. Dion** - motion to fund <u>01-4210-7-700-1 Police Cruisers</u> at \$56,448.00. **P. Bergeron** – second. All in favor. **Motion passes.**

Chief – reminds the commissioners that with the cruiser line reduction this year, there will be a substantial increase being sought next year, going from \$56,000.00 to approximately \$72,000.00.

D. Dion - motion to adjourn at 7:59 PM. P. Bergeron - second. All in favor. Motion passes.
