Mr. Eaton moved to approve the Consent Agenda as presented; Mrs. Phillips seconded the motion; all were in favor, the motion passed unanimously.

Parks & Recreation Commission – Fundraising

Mrs. Hiltz indicated that the Parks and Recreation Commission would like to undertake a fundraising effort to fund a firework display at this year's June 4th event. Mrs. Hiltz explained that the Budget Committee did not approve funding the fireworks through the budget, they didn't want taxpayers footing the whole bill so the Commission intends to reach out to local business for donations. Mrs. Phillips asked how much money the Parks and Recreation Commission needs for this. Mrs. Hiltz stated \$5,000 to \$7,000. Mr. Nye noted that the Parks and Recreation Commission are looking for donations for a clubhouse too. Mrs. Phillips suggest that the Parks and Recreation Commission put their requests in writing so what they would like to do is spelled out. Mr. Eaton and Mr. Headd Page 2 of 5

agreed with this suggestion. Mr. Headd asked how the donations are handled for the proposed skateboard park. Mr. Herman explained and suggested that the Parks and Recreation Commissions proposed efforts be handled the same project by project.

New Business

Approval of Emergency Operation Plan

Ms. Lafond explained that at the direction of Fire Chief Phillips she has updated the town's Emergency Operation Plan, not much needed to be changed but formatting, dates and minor amendments to department or individuals duties.

Mrs. Phillips moved to adopt the updated Emergency Operation Plan; Mr. Eaton seconded the motion; all were in favor, the motion passed unanimously.

The Board signed the document.

Approval of Auditors Engagement Letter

Mr. Headd explained that the Board had previously approved of changing auditing firms for the town's annual audit and the funds have been budgeted for.

Mr. Eaton moved to accept the engagement letter for services provided by Vachon, Clukay & Company, PC and authorize Chairman Headd to sign the on behalf of the town; Mrs. Phillips seconded the motion; all were in favor, the motion passed unanimously.

Highway Garage Rood Proposals

Mr. Herman stated that 4 bids were received. The Board reviewed and discussed the bids. Mr. Eaton noted that E. Guimond Construction was not replacing the roof per their bid. Mr. Headd noted that Score Construction would be taking off the existing roof. Mr. Eaton asked if the insulation needs to be replaced then. Mr. Dross and Mr. Michael Rolfe did not believe so. Mr. John Rolfe did not believe that the insulation was attached to the roof and believed that the insulation was installed after the current roof was put on. Mr. Rolfe asked what type of warranty the vendors were proposing. The Board compared the bids warranties and the steel gauges. The Board determined that they would like the roof replaced. Mr.

Eaton stated he would support awarding the bid to Score Construction but he would like to know that the warranty is. Mr. Headd and Mrs. Phillips agreed

Other Business

Mr. Herman noted that the Board is in receipt of a letter from the NH Department of Revenue Administration who has determined that the town's overall equalization assessment-sales ratio for the land, buildings and manufactured housing in the town for Tax Year 2015 to be 94.6%

Mr. Vieira noted that the actions of the Police Department and the Dross trial was brought up last week. Mr. Headd indicated that the Board has a meeting with Town Counsel tomorrow morning to discuss matters. Mr. Vieira stated that he would like the town to pay for the transcripts from the trial so that the details can be set straight. Mr. Vieira commented that he has spoken with his own lawyer and the court proceedings were and are public information.
