### Municipal Resource (MRI) Profession Services Agreement

Mr. Headd continued that the Boards intent is to then follow with a study of the Fire Department and the Town Hall as well. Mr. Headd noted that the Police Commission had relayed concerns which the Selectmen have read but he would still move forward with the agreement. Police Commissioner, Glenn Shaw indicated that he meet with the other Commissioners after the concerns were relayed and brought forth some information to them, he would be willing to discuss the information with the Board of Selectmen in non-public but the Police Commission is not going to oppose the study of the Police Department being done if a full study of the town is to be done.

Mrs. Phillips moved to accept and enter into the proposed agreement to retain professional consulting services provided by Municipal Resources, Inc. in the amount of \$14,000; Mr. Eaton seconded the motion; all were in favor, the motion passed unanimously.
