CHIEF'S REPORT

Chief – mentions as good weather approaches community interaction and activities will be picking up. He mentions the PD participation is the Walking Club for May 22nd. He comments on the 4 boxes of prescription drugs turned in at April's Drug Take Back event. He comments that the Radar Trailer is being deployed again. **D. Dion** – mentions noticing the visibility of the sign slows traffic in both directions. **Chief** – comments if residents have concern areas, they can contact the office. He mentions the K9 fundraising efforts to date have raised \$3250. He comments that K9 classes will begin in the fall. **D. Dion** – mentions goal was by Duck Day to be fully funded. **Chief** – mentions the Peer-to-Peer Program, commenting Candia and Chester PD are involved and Lt. Chabot is working on policies. He mentions the training for June is taser recertification and stop sticks and mentions the DCYF training in April. He mentions June 14th is Flag Day and the department will be holding its second annual ceremony and if residents want to drop off retired flags for their proper disposal at 11:00 am.

LIEUTENANT'S REPORT

Lt. Chabot – comments on the 141 MV stops and 11 summonses. He comments on the 19 reports generated ranging from AOC calls to RO violations. He mentions the 8 arrests and 726

calls for service. **D. Dion** – mentions the 16 hands free, commenting April was a concentration month with grant funding. **Chief** – confirms.
