News from the Auburn Town Hall

Expanded Water Testing at Landfill Property

Since closing the Town's landfill in 1996, the Town has been required by the NH Department of Environmental Services (NHDES) to conduct at least annual tests of water from four monitoring wells installed as part of the landfill closure project. The Town historically has received good results from these monitoring tests.

This past year, the NHDES sought to have the testing expanded at all closed landfill sites around the state to include detection of PFCs, which had not previously been part of the monitoring testing. When water samples were pulled in April, results indicate PFCs were detected in all of the site wells. The numbers for PFOs and PFOA (combined) of 70 ng/l was exceeded in Monitoring Well 3 and Monitoring Well 4 samples (134 ng/l and 87 ng/l respectively).

Based on these results, NHDES requested the Town perform additional tests on two groundwater sample points on the landfill property and the dug well on the landfill property, in addition to two residential wells located within 500-feet of the monitoring wells that had the slightly elevated results.

In June, these water samples were taken and tested. The results show similar elevated results for the groundwater samples and the well on the landfill property, while the two residential wells had results that were below acceptable levels.

The Town has provided all test information to the NHDES, as well as the owners of the two residential wells tested. At this point, the Town does not anticipate any additional action being required this year.

PELRB Rules in Favor of the Town of Auburn

The NH Public Employee Labor Relations Board (PELRB) issued a decision on June 19th which dismissed an unfair labor practice complaint against the Town of Auburn and the Police Commission that had been filed in October 2016 by the Auburn Police Union.

The complaint focused on the Commission's decision to hire an independent firm to investigate a police misconduct complaint. The Union complained the action was contrary to the general operating policy of the police department and was subject to mandatory bargaining. In its response, the Town stressed the decision to hire a third-party investigator is within the Police Commission's exclusive managerial prerogative and is not a mandatory subject of bargaining.

Both sides agreed to waive a formal hearing on the complaint and submit the case for decision on written briefs based on a jointly presented stipulation of facts. These documents were submitted in February 2017.

The decision summary unanimously approved by the three-member PELRB states: "The Commission was not obligated to negotiate the selection of a third party consultant like Tideview as charged by the Union, nor was the Commission obligated to impact bargain with the Union over its decision in the circumstances of this case. The Union's complaint is dismissed."

Town to Offer Property for Sale

The Board of Selectmen have been reviewing nearly 14 different properties the Town has taken possession of since 1976 with an eye towards potentially offering property for public sale. All of these properties have been acquired by Tax Collector's deed over the years.

As part of the review process, the Board received zoning determination information from Code Enforcement Officer Carrie Rouleau-Cote for the various properties under consideration.

Three properties on Appletree Road and Pinetree Road are going to be offered for sale through a public auction process, while potentially an additional two or three lots may be offered for sale by sealed bid. These lots either don't have road access or have other conditions that would restrict their ability to be a stand-alone lot, but could have interest to abutting landowners.

The Board is also looking at the potential of performing a selective cut of timber on other properties under Town ownership. Most of the properties are either "green space" lots or lands being held for open space and conservation purposes.

Special Primary Election on August 8th

The Towns of Auburn, Chester and Sandown will be holding a special election this summer to fill one of the State Representative positions in Rockingham District #4. The position became vacant with the passing of Rep. William Polewarczyk of Chester.

The Governor and Executive Council approved a Primary Election date of Tuesday, August 8th and a Special Election date of Tuesday, September 26th.

Three Republican candidates have filed for this position including James E. Devine of Sandown, James F. Headd of Auburn and Anthony S. Rossignol of Chester. A sole Democratic candidate is Kari Lerner of Chester, while there is also a single Libertarian candidate, James D. Jarvis of Sandown. The August 8th Primary election will be held to select who will be the three different party nominees.

For the September 26th Special Election, the candidates who with the Democratic, Libertarian and Republican nominations on August 8th will appear on the ballot.

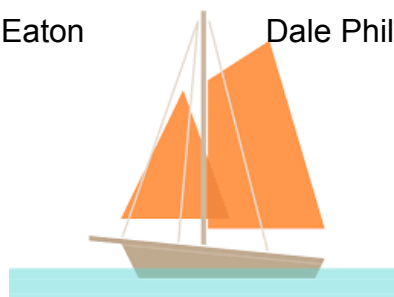
The individual elected by voters at the September 26th Special Election will fill the remaining term of the late Representative Polewarczyk through the end of December 2018.

School Improvement Committee Charter as of 7/11/2017

I. PURPOSE / MANDATE

The purpose of the School Improvement Committee is to:

- ☐ Support the School Board on renovation goals
- ☐ Advise the School Board on funding options
- ☐ Development and Implementation of a marketing plan

The School Improvement Committee will be an active contributor to the success of the renovation of Auburn Village School. II. COMPOSITION

The School Improvement Committee will be comprised of 14 members:

The Committee will be led by a Committee Chair who will be selected at the first Committee meeting by the members of the Committee.

III. WORKING and TIME COMMITMENT

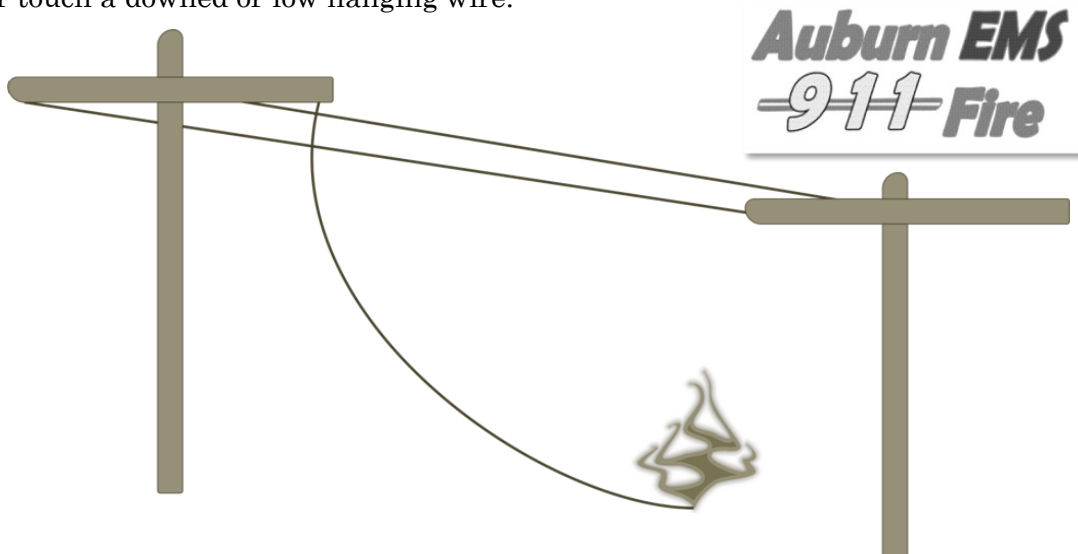
Road Closures

From time to time it becomes necessary for the Fire Department to close a road. While we realize this is an inconvenience it is a necessary part of our job to ensure the safety of the citizens and First Responders. Most of the time these closures are related to power lines either down or entangled in trees or branches. These emergencies present a different list of concerns than other types of calls.

1. The raw power of electricity. When a primary line (highest on the pole) contacts the street it immediately turns the pavement to black glass by melting the tar to a liquid that then cools to glass. What would that energy do to your body or vehicle?
2. We never know which direction the power is being supplied from. We also can't see or measure the high voltage traveling through the lines, therefore we always assume a line is live.
3. Even today people still back feed home generators through the electrical panels of their homes sending energy into their home and back into the circuit at the streets. This creates a significant danger to power crews and anyone around the wires.
4. Sometimes the power company will restore a line only to find out that another problem exists further down the road. This sends a surge of electricity back through the system and reenergizes the line until it shorts itself out again. Imagine what would happen if you were touching that wire when the energy was turned on further down the circuit. Very few people survive those injuries and none of them are ever found without serious injury.
5. Trees on fire contacting wires can at any second burn through the wire and send an energized wire falling onto the roadway or your vehicle.

Safety Tips

1. When in doubt call 9-1-1
2. Stay at least two full poles away from the downed wire or tree on the wire.
3. Assume the line is energized or may soon become energized and block the roadway to protect others.
4. Find a different way around. Learn about new areas of town. Plan ahead always have an alternate route.
5. Never touch a downed or low hanging wire.
